Medair within its programs implemented in Afghanistan invites service providers to submit a quotation for LP-KBL-23-065; Solar powered back-up system for Medair UZG ( Trinkot, Dehrawood and Chinarto) Base.

**The project refers to the Supply and installation of solar panels and a connected battery back-up system at Medair's UZG office.**

The back-up system will be charged by the solar panels as well as by city power and generators in the case of cloud coverage or other impeding circumstances. The solar panels will be installed on the roof of the office building. When the batteries are full, excess power generated by the solar panels should feed other office power needs.
